

Call for proposals for the acknowledgment of contributions in favor of researchers and professors coming from university institutions in Ukraine and hosted as visiting researchers and visiting professors at the Università degli Studi del Piemonte Orientale.

(Urgent Rectoral Decree n° 604/2022, Prot. n° 49265, April 21, 2022)

Art. 1

Aims

The **Università degli Studi del Piemonte Orientale** intends to activate support measures for researchers and professors, so that they can carry out their study, teaching and research activities at the **Università degli Studi del Piemonte Orientale** as visiting researchers and visiting professors. This opportunity is aimed at subjects who enjoy **the temporary protection regime as established by the Decision of Execution of the European Council of 04/03/2022 (EU 2022/382)**.

Under this call, researchers and professors from Ukrainian academic institutions may spend a period of 6 months at the University, in presence, to carry out teaching and / or research activities at a Department, which must ensure the availability of an individual workstation dedicated solely to the guest.

The mobility period must begin within the deadline established by the Italian Government for the current state of humanitarian emergency, set at 31 December 2022.

Article 2

Available contributions

The contributions are intended for the remuneration of visiting researchers and visiting professors and / or to cover their travel expenses, food and / or accommodation, and will be determined based on the actual period of stay.

In particular, contributions are foreseen for n. 3 researchers and/or professors, for a monthly amount equal to € 2,000.00 gross of the costs that shall be borne by the University, including the travel expenses and the accommodation, and for a period not exceeding 6 months.

Art. 3

Submission of applications

Interested parties must submit their applications as follows:

1. by e-mail, to progetti.didattica@uniupo.it;
2. by attaching the appropriate documentation, in Italian or English.



In particular:

- a. study, research and/or teaching project to be carried out at the **Università degli Studi del Piemonte Orientale**, drafted by the interested party;
- b. detailed CV;
- c. indication of the researcher/professor of the **Università degli Studi del Piemonte Orientale** who will be the scientific referees of the candidate.

Applications may be submitted by "open call" starting from the date of publication of this call and until November 30, 2022, unless the funds are available before the deadline.

Priority will be given to applications from individuals who do not already hold a position as a visiting scholar at other universities.

Applications will not be accepted if they are incomplete, contain false statements or are received, even partially, after the deadline.

Art. 4

Selection of applications and publication of results

The applications will be promptly evaluated by a Commission appointed by a subsequent rectoral measure.

The Commission will publish the results, as well as to those interested, to the scientific sponsors as well as to the competent Departments.

In order to start the activities at the Departments, the beneficiaries of the grants will have to submit a copy of the declaration of presence issued by the immigration office of the Questura upon entry into Italy.

Art. 5

Management of grants

The competent Departments will manage the drafting of contracts, relations with the competent reception offices (Police Headquarters, Prefectures, Provincial Labor Departments, Revenue Agency, etc.) and any other necessary practice, in accordance with the provisions of Art. 2, as well as with the University regulations.

The Departments are required to send to the Higher Education Sector of the Central Administration, by e-mail (progetti.didattica@uniupo.it), a copy of the contracts signed with the beneficiary visiting researchers and visiting professors.

Art. 6

Final Report



The scientific referees will be required to produce within 60 days after the end of the activities a final report on the funded mobility and the results obtained. This report will be submitted in particular to the competent Department, as well as to the Higher Education Sector of the University Central Administration.
