Measures for the attraction of international students and for the Ukraine emergency: call for application (D.R. rep. n°1447/2022, prot. n° 123704 del 16/09/2022)

Deadline for application: October 7th, 2022 at midday

Art. 1 Subject

This call aims at providing measures for the attraction of international students and for the Ukrainian emergency.

The measures (approvation act: delibera del Consiglio di Amministrazione n. 10.1 del 25.03.2022) are related to the intervention areas specified below:

Action A) - ATTRACTION OF INTERNATIONAL STUDENTS - UKRAINIAN EMERGENCY for the provision of scholarships, purchase of technical supports and teaching materials, reimbursement of the enrollment fee and coverage of costs related to accommodation (see the table below):

Action B) ATTRACTION OF INTERNATIONAL STUDENTS, coming from other geographical areas, for the provision of 10 scholarships, each one of € 6,000 euros inclusive of charges as results in the table below:

Art.2 Requirements

The requirements for application, relating to the academic year 2022/2023, are the following ones:

Action A)

Students with Ukrainian citizenship and recognition of the status of holders of international protection or special protection

- Merit requirements

- Enrolled at the UPO, for the academic year 2022/23 (or students who are not yet enrolled, but are going to), in a bachelor degree, master degree or single cycle master's degree;

Action B) 10 scholarships divided as follows: 7 scholarships per students enrolled in 1st years and 3 scholarships for students enrolled in successive years

International students who meet the following merit and income requirements:

- Merit requirements

- Enrolled at the UPO, for the academic year 2022/23 (or students who are not yet enrolled, but are going to), in first year of a bachelor degree, master degree or single-cycle master's degree

- Enrolled, for the academic year 2022/23, in successive years with the following minimum credits registered by August 10th 2022:

- Students enrolled in course or repeating not more than 1 year with respect to the normal expected course duration;

- Students who are regular with student contributions.

- Income and assets requirements

- ISEE \leq € 24,335.11 and ISPE \leq € 52,902.43

Art.3 Methods for submitting the application

The application must be submitted completing the online form available at the link: <https://forms.gle/YxoabuwfM9AB2zNv6>.

Other procedures are not allowed.

It is possible for each student to apply for the call only once, by choosing only one of the two actions (action A or action B).

The deadline for submitting the application is **October 7th 2022, 12.00**, under penalty of exclusion. The application must be accompanied by:

- for students who apply for action A: the document certifying the recognition of the status of holder of international protection / holder of special protection;
- for students who apply for action B: the ISEE 2022 certification, issued starting from January 2022, or the receipt of the presentation of the DSU (Single Substitute Declaration), if the ISEE certificate has not yet been issued. Only certificates valid for the right to university study will be accepted, with reference to the tax code of the student candidate for the procedure and without annotations, omissions and discrepancies.

Art.4 Criteria for determining the ranking list

The Commission, specifically identified, will verify the applications received within the deadline and carry out the evaluation of the students requesting the benefits.

The Commission will draw up two distinct rankings, the first with reference to action A) and the second with reference to action B), based on the parameters reported below.

Only for action B, with the same merit, the lowest ISEE value will be taken into account. In the case of ISEE 2022 certificates bearing the same value, the candidate with the lowest age will prevail.

The maximum score, equal to 100, for the formulation of the ranking will be determined on the basis of the following parameters:

1) parameter of merit (maximum 50 points)

- Students enrolled in the first year of a bachelor degree or single-cycle master's degree will be assigned a score based on the grade of the high school diploma according to the following scheme :

- secondary diploma grade from 60 to 75 → points 15
- secondary diploma grade from 76 to 89 → points 25
- secondary diploma grade from 90 to 95 → points 35
- secondary diploma grade from 96 to 100 → points 50

For the conversion of marks, the Commission will use the ministerial table referred to in Annex 5 to the Ministerial Decree n. 313 of 20/05/2016 available at the link http://attiministeriali.miur.it/media/277372/allegato_5_conversione%20titoli.pdf

- Students enrolled in successive years of bachelor'and master'degree, including single-cycle will be assigned a score (X) calculated as follows:

$X = (N^{\circ} \text{ of credits acquired}^2 / N^{\circ} \text{ of credits from previous academic years study plan}) \times 50$

² In the case of integrated exams, the credits relating to each partial exam must be obtained and validated by 10 August 2022.

- Students enrolled in the first year of Master's Degree Courses will be assigned a score based on the grade of the graduation grade according to the following scheme:

- graduation grade from 66 to 78 → points 15
- graduation grade from 79 to 89 → points 25
- graduation grade from 90 to 99 → points 35
- graduation grade from 100 to 110 → points 50

For the conversion of graduation marks, the Commission will use the ministerial table referred to in Annex 5 to the Ministerial Decree n. 313 of 20/05/2016 available at the link http://attiministeriali.miur.it/media/277372/allegato_5_conversione%20titoli.pdf

2) income parameter, based on the ISEE 2022 value (maximum 50 points):

- 0> ISEE <5000 € → 50 points
- € 5001> ISEE <€ 10,000 → 25 points
- 10001> ISEE <€ 15,000 → 15 points
- 15001> ISEE ≤ € 24,335.11³ → 5 points

Art.5 Methods of disbursement

Students with a suitable position in ranking list, considering their score, will be given support measures until the budget available for each action is exhausted.

Support measures will be paid in three installments:

- the first one (40% of the total amount) by **November 30th 2022**;
- the second one (40% of the total amount), by **February 28th 2023**, if the student has earned at least 10 credits;
- the third one (20% of the total amount), by **July 31st 2023**, if the student has earned at least 20 credits.

Students are expected to complete their matriculation / enrollment process within the deadlines set by Manifesto degli Studi a.y. 2022/23 in order to receive the benefits.

Art. 6 Prohibition of accumulation

The contributions relating to actions A) and B) referred to in art. 1 of this call for applications cannot be combined with other scholarships, contributions and loans granted in application of current legislation on the right to education, nor with scholarships provided by other institutions.

The exemption from payment of university fees does not constitute a cause of incompatibility with the contribution.

In the application students must indicate under their direct responsibility not to be winners of scholarships, grants and loans granted in application of current legislation on the right to education, or grants provided by other institutions.

If the candidate is winner, for the same academic year, of another scholarship / contribution / funding subsequent to the assignment of the grant referred to in this call for applications, he/she

must immediately notify the University, declaring whether he/she intends to keep the grant or opt for other scholarship / contribution / financing.

The option right can be exercised by **October 30th 2022**.

Art. 7 Revocation of contributions

The contribution will be revoked:

- if substantial discrepancies are found between what was declared by the student and his/her actual economic and financial situation;
- if the student has received other scholarships / contributions / funding for the same academic year, except as specified in the last paragraph of the previous art. 6.

The University will recover the sums paid through the mechanisms provided for by law.

Art. 8 - Treatment of personal data

The data transmitted by the candidates will be processed only for the purposes related to the management of the procedure, in compliance with the laws regarding the protection of personal data (EU Regulation 2016/679 - "GDPR" - Legislative Decree 196/2003, as amended by Legislative Decree 101/2018 - Code regarding the protection of personal data - and all the relevant provisions of the Authority for the protection of personal data and the European Committee for the protection of personal data.

The provision of data is optional, however if candidates do not provide the data, the University cannot guarantee them to participate in the selection.
