The candidate must have documented competence in: i) study and analysis methods suitable for the interpretation of proteomics, metabolomics, transcriptomics data obtained from investigations carried out on human primary biological samples and biological samples derived from in vivo and in vitro models; ii) functional assays on in vitro models designed to validate biochemical pathways and biomarkers associated with aging and / or diseases associated with aging; iii) creation of 3D models; iv) principles of biobanking and strategies for the analysis of biomarkers in population studies; v) conducting research projects and collaborating with other study groups at national and international level.</p> <p>The Scientific Responsible is Prof.ssa Daniela CAPELLO.</p>

RESEARCH ACTIVITIES	The research activities envisaged are part of the lines of the sector to which they belong and concern the general theme of social networks and the composition of professional and informal services in the provision of care to the elderly and frail. More specifically, the research will have to contemplate the analysis of the relationships between participants in inter-professional and intersectoral networks between formal providers of services and care, but also the composition of informal networks from the perspective of the users of services to support frailty. It involves analyzes with both quantitative and qualitative techniques. It is proposed to evaluate the new welfare policies in local contexts with a different composition of supply and use networks in the proximity care system. Particular attention will be paid to local care systems, both formal and informal, in an aging society with parental and generational networks in the process of shrinking and verticalization. The research will ultimately have to evaluate the effects of new policies in support of aging and produce policy suggestions in heterogeneous geographic areas with differently distributed services.

This is a research program on aging and ageism in Italy, based on an extended and interdisciplinary partnership funded by the PNRR. Within the Spoke 7 Cultural and political dimensions of aging societies, the research intends to build a holistic vision of the cultural and political aspects of aging and to propose lines of change applicable in the different dimensions of society, also including the perspective of professionals working in organizations dedicated to the elderly population.</p> <p>The empirical analysis aims at studying forms of discrimination based on age prejudices and cultural stereotypes underlying ageism, with attention also to gender differences.</p> <p>The task will be articulated, firstly, in an analysis of the prevailing narratives and, secondly, in the study of the professional practices activated in the health and social services dedicated to the elderly. This study will be conducted through interviews, focus groups and document analysis.</p>
